In case of ingestion gastric lavage should be considered in cases of significant ingestions only within the first 2 hours. However, the application of activated charcoal and sodium sulphate is always advisable. Symptoms of poisoning may appear several hours later. Keep under medical supervision for at least 48 hours.

Fipronil caused reproduction toxicity in a two-generation study in rats only at dose levels also toxic to the parent animals. The reproduction toxicity seen with Fipronil is related to parental toxicity.

Fipronil did not cause developmental toxicity in rats and rabbits.
